

1. Eligibility: The **pFITE24** contest is open to eligible parties worldwide who submit an entry video to Home Stage. There is no age limit for applicants. This contest is subject to national, international, and local laws and regulations and void where prohibited by law.

2. Sponsorship. The sponsor is Home Stage, trading under Morston Palatine, (“Sponsor”), located at 1 Hilltop Retreats, Langham Road, Blakeney, Norfolk, NR25 7PR. The Sponsor will conduct the contest substantially as described in these Official Rules.

3. Agreement to Rules: By entering this contest, the Entrant (“You”) agrees to abide by the Sponsor’s Official Rules and decisions, which are fully and unconditionally binding in all respects. The Sponsor is not responsible, nor shall have any liability, for Winner's failure to receive notices due to email security settings that may cause notifications to be marked as spam or junk email. Nor shall the Sponsor be liable for the Winner's provision of incorrect or otherwise non-functioning contact information. If the Winner 1) fails to claim the prize within 15 business days from the time the award notification was sent, 2) is found ineligible, or 3) does not complete and return an executed declaration and release within the specified timeframe, the prize may be forfeited, and an alternate Winner may be selected. Terms & Conditions: In its sole discretion, the Sponsor reserves the right to modify, suspend, cancel, or terminate the **pFITE24** contest should non-authorized human intervention, a bug or virus, fraud, or other causes beyond the Sponsor's control, impact or corrupt the security, fairness, proper conduct, or administration of the **pFITE24** contest. The Sponsor, in the event of any of the above issues, may determine the Winner based on all eligible entries received prior to and/or after (if appropriate) the action taken by the Sponsor. Individuals who tamper with or attempt to tamper with the operation or entry process of the contest or website or violates these Terms & Conditions will be disqualified by the Sponsor in its sole discretion. from the competition whilst an investigation takes place, after which point the Sponsor may decide to reinstate the entrants submission, or permanently remove the entry.
